RESPONSIBILITY OF THE LICENSED CONTRACTOR:

All site preparation, infrastructure, County and State permits, delivery and installation of the equipment shall be as specified in the proposal, and responsibility for the equipment and operation remains with the contractor until satisfactory completion of acceptance tests and formal written acceptance by MEO.

Comply with needed EPA, OSHA and any other federal, State or County agencies that would regulate this project.

Pursuant to Section 103D-328, HRS, Contractor shall be required to submit a tax clearance certificate issued by the Hawaii State Department of Taxation (DOTAX) and the Internal Revenue Service (IRS) with the bid documents.

Compliance with Section 103D-310(c), for an Entity Doing Business in the State of Hawaii Compliance Express:

Permits, License, and Taxes:

The Contractor shall procure all permits and licenses, during the contract term, pay all charges, fees, and taxes, and give all notices necessary and incidental to the due and lawful prosecution of the work.
