- Souimw mi tongeni wau esinesin ngeni ekkew souimweim rese moni ar rent me 45 ran esinesin ren an epwe ne wesino ewe lease poputa non August 7, 2021 atun epwe pwan poputa angangen katou.

Ika pwe kose fori omw fansoun ren ei pekin affor nefinom me noum we souimw, iwe ewe angangen kepung faniten atokkou epwe muttir poputa lupwen epwe mwuch ewe 15 ran.

- Noum we souimw ese tongeni epwe nokeno imwomw we me esipano omw konik me fifi ika ese wor taropwe e katou seni soukapung. Ika pwe om we fifi me konik re ofono iwe ka tongeni faien eu Temporary Restraining Order (TRO) an noum we souimw esap arapoto ngeni neniom ika kanoto unukum.
